NOTIFICATION
Dated 28th March, 2011

Whereas, a detailed schedule for the conduct of General Election to the Panchayats in the entire State was issued by this office on 14th March, 2011;

Whereas the schedule for conduct of election was discussed in the Legislative Assembly and a number of Hon'ble Members of the Legislative Assembly voiced the opinion that keeping in view the migration pattern of the nomadic/migratory population, the schedule for the conduct of General Election to the Panchayats in respect of the Blocks/Districts having a fair proportion of migratory/nomadic electors, belonging to Gujjar and Bakkarwal community, should be preponed/suitably modified so as to enable them to take part in the electoral process;

Whereas, the issue was discussed with the District Panchayat Election Officers (Deputy Commissioners) of Reasi and Rajouri Districts and with the concerned police authorities;

Whereas, the District Panchayat Election Officers (Deputy Commissioners) Rajouri and Reasi vide their letter No.ENT/R/11/183 dated 23-03-2011 and No.DPO/Rsl/10-11/892 dated 26-03-2011 respectively, have also requested to re-schedule the dates of elections, so as to enable these migratory/nomadic electors to exercise their franchise;

Whereas, a communication has also been received from District Panchayat Election Officer (Deputy Commissioner) Doda vide his No.ENT/D/11/2342 dated 15-03-2011, wherein he has requested for preponement of elections in Block Thatri in 10th phase instead of 14th Phase due to the shortage of polling staff;

Whereas, the rescheduling of election dates in the Districts of Rajouri, Reasi and Doda would necessarily result in the change of dates in respect of certain Blocks in District Jammu as well;

Now, therefore, the dates for the conduct of elections in the Districts of Doda, Reasi, Jammu and Rajouri Districts, are rescheduled as under:-
