## **NOTIFICATION**

Whereas, in pursuance of Rule 7 of the J&K Panchayati Raj Rules, 1996, the Government had issued a Notification, in consultation with the Election Authority (Chief Electoral Officer, J&K), vide its SRO No.78 dated 14<sup>th</sup> March, 2011, calling upon the Panchayat Halqas in the State to elect Sarpanches and Panches on the dates to be appointed by Election Authority (Chief Electoral Officer, J&K);

Whereas, in pursuance of Rule 8 of J&K Panchayati Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) had issued a Notification on 19<sup>th</sup> April, 2011, notifying the dates for the 9<sup>th</sup> Phase of Election for Sarpanches and Panches in respect of Blocks Tangdhar, Singhpora, Sumbal, Srinagar, Khoveripora, Kishtwar, Ramban, Kathua and Marh as per the schedule given below:-

- a) 19th April, 2011 as date of issue of Gazette Notification,
- b) 26<sup>th</sup> April, 2011 last date for making Nominations,
- c) 27th April, 2011 date of Scrutiny of Nominations,
- d) 29th April, 2011 last date for withdrawal of candidate,
- e) 16th May, 2011 date of poll/counting wherever, necessary,

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Anantnag vide his letter No.DPEO/Election/2011/4872 dated 11-05-2011 has intimated that as per Rule (4) of the J&K Panchayati Raj Rules, 1996, the Electoral Roll of Panch Constituency AN-146-Hugam-VI (Pandith Mohallah) Panchayat Halqa Hugam of Block Khoveripora was prepared in which the names of electors figuring in the Electoral Roll of Pandith Mohallah (Hugam) of the Assembly Constituency No.45-Bijbehara automatically became a part of the Electoral Roll of said Panch Constituency;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Anantnag has further intimated that during the course of the preparation of the marked copy of Electoral Roll for the Panch Constituency AN-146-Hugam-VI (Pandith Mohallah), out of 173 electors, only two electors have been found presently residing in the said Panch Constituency

AN-146-Hugam-VI (Pandith Mohallah) and the remaining 171 voters have been found to have shifted/migrated from the said Constituency;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Anantnag has requested that in view of having only two electors in the Panch Constituency AN-146-Hugam-VI (Pandith Mohallah), for which the elections for Panch/Sarpanch for the said Panch Constituency are going to be held on 16<sup>th</sup> May, 2011, he may be allowed to shift these two electors to the nearby Panch Constituency i.e., AN-146-Hugam-V;

Whereas, the Election Authority has perused the report of District Panchayat Election Officer (Deputy Commissioner) Anantnag and vide this office letter No.5328/CEO/PYT/2011/6108 dated 12-05-2011 allowed the District Panchayat Election Officer (Deputy Commissioner) Anantnag to shift the two electors from Panch Constituency AN-146-Hugam-VI (Pandith Mohallah) to the nearby Panch Constituency i.e., AN-146-Hugam-V to enable them to exercise their franchise;

Now, therefore, in exercise of the powers conferred under section 36 of the J&K Panchayati Raj Act, 1989 read with rule 3 of J&K Panchayat Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) hereby rescinds its Notification dated 19<sup>th</sup> April, 2011 issued in pursuance of Rule 8 of J&K Panchayati Raj Rules 1996 in so far as it relates to the Panch Constituency AN-146-Hugam-VI (Pandith Mohallah) Panchayat Halqa Hugam of Block Khoveripora for both Sarpanch as well as Panch.
