Whereas, in terms of the Notification dated 26-10-2018, *inter alia*, various dates for conduct of elections were appointed to elect Sarpanches and Panches for Halqa Panchayats of **Block Kangan** District Ganderbal; and

Whereas, in view of the interim order dated 24-10-2018 passed by Hon'ble High Court in OWP No. 2014/2018 titled Inhabitants of Halqa Chattergul-A versus State and others, the election process was suspended from 01-11-2018 in Halqa Panchayat Chattergul-A; and

Whereas, pursuant to the said direction of the Hon'ble Court, the matter was duly considered by the Election Authority (Chief Electoral Officer, J&K) and a consideration order dated 02-11-2018 was passed; and

Whereas, Hon'ble Court vide its order dated 19-11-2018, while deciding the application moved by Election Department for vacation of the status quo order dated 24-10-2018, has observed that there was no need to file such application as the mandate of the said interim order has already been carried out by considering the matter and passing of an appropriate order by the respondent authority (Election Authority); and

Whereas, perusal of the order mentioned supra reveals that the Election Authority can proceed ahead with the election process in the Halqa Panchayat, **Chattergul-A**, since there being no restraint or stay order in this regard.

Now, therefore, in exercise of powers under section 36 of J&K Panchayati Raj Act, 1989, read with Rule 8 of the J&K Panchayati Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K), in order to recommence the election process that has been suspended as the matter was subjudice, hereby notifies and, accordingly, appoints the following dates for the conduct of elections to elect Sarpanches and Panches in respect of the Panchayat Halqa Chattergul-A of Block Kangan of District Ganderbal, as under:

- a) the 24th November, 2018 (Saturday) as the last date for making nominations.
- b) the 26th November, 2018 (Monday) as the date for the scrutiny of nominations.
- c) the 28th November, 2018 (Wednesday) as the last date for withdrawal of candidature.
- d) the 08th December 2018 (Saturday) as the date on which a poll, if necessary, shall be taken from 08:00 a.m. to 02:00 p.m.
- e) the 08th December 2018 (Saturday) as the date of counting, unless notified otherwise.
- f) the 17th December, 2018 (Monday) as the date before which the election shall be completed.
