Whereas, on the date of scrutiny, the nomination papers of Mohd. Ashraf S/o Mohd. Moosa were rejected by the concerned Returning Officer, stating that the name of the applicant does not figure in the electoral roll of Ward No 3 of the said Panchayat Halga;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Doda, has reported that after the addition/deletion upto the last date of nomination i.e. 05.11.2018 by the BDO concerned, the name of the applicant figures in Ward No 3 Sarantani at S. No. 93 in the supplementary voter list;

Whereas, in view of the above, the rejection of nomination papers of Mohd Ashraf on the grounds stated above is wrong on the face of records;

Now therefore, the Election Authority, in exercise of powers vested under section 36 of the Jammu and Kashmir Panchayti Raj Act, 1989, orders as under:

- i. The nomination papers of Mohd Ashraf S/o Mohd Moosa shall be treated as valid.
- ii. A revised list of validly nominated candidates shall be issued.

iii. The date of withdrawal of candidature for the Ward No 3, Panchayat Halqa Daryote, shall be 12th November. 2018.
