Whereas, in terms of the Notification dated 29-10-2018, inter alia, various dates were appointed for the conduct of elections to elect Sarpanchs and Panchs for Halga Panchayats of Block Nangali Sahib Sain Baba of District Poonch; and

Whereas, one Kaneez Fatima, W/o Mohd, Rashid, R/o Ward No. 05, Panchayat Halga Noonabandi had also filed her nomination for Panch in ward No. 05, Noona Bandi (Mohalla Matha) Panchayat Halqa Noona Bandi, Block Nangali Sahib Sain Baba but the same was rejected on the date of scrutiny by concerned Returning Officer; and

Whereas, aggrieved of the same, an appeal was filed by her before the Election Authority and the same has been decided in her favour vide order No.: CEO/Pvt/2018/718 dated 20-11-2018, and

Whereas, such improper rejection has resulted in vitiation of the election process from the date of scrutiny onwards for the Panch constituency in ward No. 05, Noona Bandi (Mohalla Matha) Panchayat Halqa Noona Bandi, Block Nangali Sahib Sain Baba and

Now, therefore, considering the above, in exercise of powers under section 36 of J&K Panchayati Raj Act, 1989, read with Rule 8 of the J&K Panchayati Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) hereby notifies and, accordingly, appoints the following dates for the conduct of elections to elect Panches in respect of the ward No. 05 Noona Bandi (Mohalla Matha) Panchayat Halqa Noonabandi, Block Nangali Sahib Sain Baba District Poonch as under:

- a) the 22nd November, 2018 (Thursday) as the date for the scrutiny of nominations.
- b) the 24th November, 2018 (Saturday) as the last date for withdrawal of candidature.
- c) the 29th November 2018 (Thursday) as the date on which a poll, if necessary, shall be taken from 08:00 a.m. to 02:00 p.m.
- d) the 29th November 2018 (Thursday) as the date of counting, unless notified otherwise.
- e) the 17th December, 2018 (Monday) as the date before which the election shall be completed.

Further, consequent upon the above, the date on which a poll, if necessary, for all or any of the constituencies of Panchayat Halqa Noona Bandi, Block Nangali Sahib Sain Baba District Poonch, notified vide Notification dated 29-10-2018, shall now be 29-11-2018 instead of 24-11-2018.
