Subject: **Annual Revision of Panchayat Electoral Roll-2019 having 01-01-2020 for eligibility.**

1. Whereas as per rule-4 (Sub Rule – 4) of the Jammu and Kashmir Panchayati Raj Rules, 1996 and SRO 690 dated : 25.10.2019, the Electoral Rolls of the constituencies of the Panchayat Halqa shall be prepared in accordance with the provisions of the Act, Rules and procedure.
2. Whereas the names included in the last updated electoral roll prepared for the Panchayat Election 2018 shall be taken as the basis for the preparation/revision of Electoral Rolls in accordance with SRO No 690 dated : 25<sup>th</sup> October 2019 issued by Government of Jammu & Kashmir Department of Rural Development and Panchayati Raj.
3. Whereas it has been decided to revise the Panchayat Electoral Rolls to the Panchayat/Panch Constituency and electors attaining age of 18 years on 01.01.2020 shall be eligible for inclusion.
4. The Electoral Registration Officers (EROs) shall get the last updated Panchayat Electoral Roll published in the Halqa Panchayat on 18-11-2019 (Monday) with a notice in Form - PER-1.
5. Now, therefore, by virtue of this notice, the Election Authority hereby publish the draft Panchayat Electoral Rolls 2019 for its revision w.e.f. 18/11 /2019 as per schedule enclosed as "Annexure- I" for inviting claims and objections regarding additions, deletions, corrections and transposition of entries in the Panchayat Electoral Rolls from the eligible electors of the area.
6. For any assistance in this behalf, the concerned District Panchayat Election Officer, Electoral Registration Officer, Assistant Electoral Registration Officer and Panchayat Election Booth Official may be contacted.
