**Subject: Revision of Panchayat Electoral Rolls with reference to 01.01.2025
as the qualifying date –Extension of date for filing claims and objections-
regarding.**

Sir,

State Election Commission has reviewed the latest weekly progress reports of claims and objections received by the Districts along with Statistical Analysis of Electoral Data Assembly Electoral Rolls vis-a-vis Panchayat Electoral Rolls besides status of punching of claims and objections by the Districts. The analysis the Commission has reveals that progress of many blocks needs improvements as huge gaps exist between the number of voters in the Assembly Rolls vis-a-vis Panchayat Rolls. The Commission has, therefore, decided to extend date for filing the claims and objections in the Panchayat Electoral Rolls up to 20.12.2024. The other stages of the revision shall be as under accordingly:-

| 3 | Disposal of Claims and Objections by ERO | 30.12.2024 (Monday) |
| 4 | Publication of Final Panchayat Electoral Rolls-2025 | 15.01.2025(Wednesday) |

The Commission has further directed that District Panchayat Election Officers shall ensure that :-


- Wide publicity be given to the Panchayat Electoral Revision at grass root level through the field staff of all Departments including Numberdars/Chowkidars to ensure that no quarter is left unaware. Publicity may also be given in all official WhatsApp Groups and Social Media.
- Panchayat Election Booth Officers (PEBOs) may be directed to visit house to house survey/visit for filling the forms of left out voters/ new voters.

c) Special Camps may be organized at Panch Ward Level.
