# PRESS NOTE

#### 1. STATE ELECTION COMMISSION:-

In terms of Section 36 of the Jammu and Kashmir Panchayati Raj Act 1989, the superintendence, direction and control of the preparation of Electoral Rolls for, and the conduct of, all elections under the Act are vested in the Election Authority to be known as State Election Commission.

## 2. <u>DISTRICT DEVELOPMENT COUNCIL (DDC) ELECTIONS:</u>

Section 45 of the Jammu and Kashmir Panchayati Raj Act 1989 envisages a District Development Council, for each District having jurisdiction over the entire district excluding, such portions of the district as are included in a Municipality or Municipal Corporation constituted under any law for the time being in force.

#### a. <u>DELIMITATION OF DDC CONSTITUENCIES:</u>

In terms of Rule 108-A(4) of the Jammu and Kashmir Panchayati Raj Rules 1996, draft Delimitation proposals in respect of all the 20 districts of the Union Territory of Jammu and Kashmir were published by all the Deputy Commissioners on 19th October 2020 and kept in public domain for inspection and inviting public objections thereon till 23rd of October 2020. Various objections and suggestions were received within the prescribed period by the respective Deputy Commissioners and each such objection/suggestion was considered by the District Level Committees as well as the Directors, Rural Development Department in detail. Objections/recommendations which were found devoid of any merit were not accepted and those found to be reasoned and in consonance with the provisions of the Jammu and Kashmir Panchayati Raj Act 1989 and Jammu and Kashmir Panchayati Raj Rules 1996 were accepted. After incorporating all the changes in respect of the objections/recommendations which have been accepted, the Election Authority, notified the Delimitation of District Development Councils, in terms of Rule 108-B, vide Notification No.EA/Pyt/2020/02 dated: 26.10.2020.

#### b. **DDC ELECTORAL ROLLs:-**

In exercise of powers vested under Section 36 of the Jammu and Kashmir Panchayati Raj Act 1989, read along with Rule 108-C of the Jammu and Kashmir Panchayati Raj Rules 1996, the Election Authority has directed that:-

"The Electoral Roll for every District Development Council Constituency shall consist of the electoral rolls for all the Panchayat Halqas comprised within that District Development Council Constituency and it shall not be necessary to prepare or revise separately the electoral roll for any such District Development Council Constituency.

The updation of electoral rolls of the constituent Panchayat Halqa of a District Development Council shall be done under the provisions of Sub-Rule 4 of the Rule 4 of the Jammu and Kashmir Panchayati Raj Rules 1996 and EROs and AEROs appointed under the proviso to Sub-Rule 4(1) of

Rule 4 shall perform all electoral roll related functions for their respective constituent Panchayat Halqas."

#### c. RESERVATION OF DDC CONSTITUENCIES:

Section 45-A of the Jammu and Kashmir Panchayati Raj Act 1989 envisages reservation of DDC seats to be filled by direct elections for Scheduled Castes, Scheduled Tribes and Women in a District Development Council. Rule 108-A (3, 3A, 3B, 3C, 3D and 3E) of the Jammu and Kashmir Panchayati Raj Rules 1996 lays down the procedure for reservation of District Development Council Constituencies in a district. Draft Reservation of DDCs in each District was notified by the Deputy Commissioners on 27th October 2020 and objections were invited till 31st October 2020. Divisional level Committees headed by Directors Rural Development Department scrutinized all these objections and made their recommendations based on which the Election Authority has examined and notified the Final Reservation Status of DDC constituencies in the UT vide Notification No.EA/Pyt/2020/03 dated 03-11-2020.

#### d. TERM OF OFFICE OF ELECTED MEMBERS:

In terms of Section 45-A of the Jammu and Kashmir Panchayati Raj Act 1989, the term of DDC shall be five years.

#### 3. PANCHAYAT BY-ELECTIONS:-

The last General Elections to the Panchayats were held in the months of November-December, 2018 and 22214 Panches and 3459 Sarpanches were returned elected by the respective Returning Officers out of 33592 Panch and 4290 Sarpanch constituencies in the UT of Jammu and Kashmir. Further, vacancies have accrued on account of death, resignation, etc of the elected Sarpanches and Panches. Also, as a result of elections of Chairpersons of BDCs in October, 2019 another 307 seats of Panches/Sarpanches fell vacant. By-elections to fill the vacant seats were earlier notified in the month of February, 2020 but had to be deferred due to unavoidable circumstances.

Now, the Government in Rural Development and Panchayati Raj Department has issued notification S. O. 304 dated 01-10-2020 under rule 7 of the Jammu and Kashmir Panchayati Raj Rules, 1996, calling upon the annexed Panchayat Halqas to elect Sarpanch(s) and Panch(s) for the vacant Panchayat Halqas and Panch Constituencies annexed therewith.

#### a. PREPARATION OF PANCHAYAT ELECTORAL ROLL:-

Revision of the Panchayat Electoral Rolls with reference to 01.01.2020 as the qualifying date was started with the publication of Draft Panchayat Electoral Roll on 18<sup>th</sup> of November, 2019 and the process was completed on 26<sup>th</sup> December, 2019. The final publication of Panchayat Electoral Rolls with reference to 01-01-2020 as the qualifying date was done on 2<sup>nd</sup> January 2020. Sufficient copies of the final electoral roll have been printed by the concerned Electoral Registration Officers and are

available for use during the election process. Apart from printed copies, soft copies of the same are also available on the website of the Chief Electoral Officer. www.ceojk.nic.in

#### b. RESERVATION OF CONSTITUENCIES:-

In pursuance of Rule 40 of the Jammu and Kashmir Panchayati Raj Rules 1996 and S.O.35 dated 27-01-2020, there shall be no change in the reservation roaster vis-a vis the General Elections to Panchayats held in November-December 2018. Thus the Notifications with regard to reservation of Sarpanch/Panch Constituencies for Schedule Caste, Schedule Tribes and Women as per provision of the Act and Rules governing Panchayat Elections issued by the competent authority i.e., Directors of Rural Development Department, J&K for the General Elections to Panchayats held in November-December 2018 shall apply for the by-elections also.

#### c. TERM OF THE ELECTED REPRESENTATIVES:-

In pursuance of sub rule 2 of Rule 40 of the Jammu and Kashmir Panchayati Raj Rules 1996 and S.O.35 dated 27-01-2020, the candidates duly elected during these by-elections shall hold office for the remainder of the period of five years commencing from the date of constitution of Halqa Panchayat.

#### 4. DETAILED STATISTICS:-

The relevant statistics in reference to the DDC seats and the vacant seats of Sarpanches and Panches to which the elections are also being held as per S.O. 336 dated 29<sup>th</sup> October, 2020 and S.O. 304 dated 1<sup>st</sup> October, 2020 respectively issued by the Rural Development Department are as follows:-

#### 5. DOCUMENTS FOR IDENTIFICATION OF ELECTORS:-

The Election Authority has decided that compulsory identification of voters will be made at the Polling Stations on the days of poll and accordingly notified a list of documents (Annexure-I) which shall be used for the purpose of identification of electors at the polling stations.

#### 6. POLLING STATIONS:-

Suitable numbers of polling stations have been notified for each DDC Constituency and vacant Panch Constituency of a Panchayat Halqa as determined by the District Panchayat Election Officer (Deputy Commissioner), depending on the number of electors in the final Electoral Roll of the Panchayat Halqa and also other factors like ease of the voters in reaching polling stations.

#### 7. BALLOT BOXES:-

These elections shall be held using 'Ballot Papers' and thus 'Ballot boxes' would be used during these Elections. Sufficient numbers of ballot boxes have been made available for the smooth conduct of elections.

#### 8. OBSERVERS:-

General Observers shall be deployed to ensure free, fair, transparent, ethical and Covid safe DDC and Panchayat By-Elections. The observers shall keep a close watch on every stage of the electoral process. Their names, addresses within the district and their telephone numbers will be publicized. Additionally, Micro Observers shall also be deployed to observe the poll proceeding at the Polling stations on the Poll day.

#### 9. ELECTION EXPENDITURE MONITORING:-

Comprehensive instructions for purpose of effective monitoring of the election expenditure of candidates have been issued. For greater transparency and for ease of monitoring of election expenses, Candidates would be required to open a separate bank account and incur their election expenses from that very account. Expenditure Observers are being appointed to keep close watch on Election Expenditure of the candidate. Control Room and complaint monitoring centre shall be operative during the entire election process. A contesting candidate has to ensure that he/she maintains day-to-day expenditure record in the prescribed register, which will be supplied to the contesting candidate in the form of 'Expenditure Register', from the date of nomination to the date of declaration of result. The

Election Authority has fixed the limits of expenditure to be incurred by the Contesting Candidates as under:-

For election as Member of DDC

Rs 5,00,000/-

For election as Sarpanch

Rs 1,00,000/-

For election as Panch

Rs 30,000/-

#### 10. VIDEOGRAPHY:-

All critical events will be videographed. District Panchayat Election Officers (Deputy Commissioners) will arrange sufficient numbers of video and digital cameras and camera teams for the purpose. The events for videography will include filing of nomination, scrutiny thereof and allotment of symbols, storage and distribution of Ballot Boxes, important public meetings, processions during campaign, process of dispatching of postal ballot papers, polling process and counting of votes.

#### 11. VOTER SLIPS:-

To facilitate the voters to know where he/she is enrolled as a voter at a particular polling station and what is his/her S. No. in the electoral roll, voter slips will be distributed to all enrolled voters by the DPEOs. It has also been directed that the said voter slip should be in Urdu and English languages.

#### 12. POSTAL BALLOTS:-

- A. In order to facilitate the Kashmiri Migrant voters to enable them to vote through Postal Ballots, "Migrant Postal Ballot" Scheme was notified for the Elections to Panchayats in 2018. The scheme shall be implemented for the By-elections 2020 too.
- **B.** However, during these By-elections, another set of 'Absentee Voters' comprising of senior Citizens (above the age of 80 years), Electors marked as PwDs, Covid Positive or 'suspect' who are hospitalized or quarantined (Home/Institutional) and employees deployed on Election Duty or Covid Duties on the day of Poll, have also been extended facility of Postal Ballot. For the Senior Citizens and Covid patients and PwDs the facility is being provided at their doorsteps for the first time in the UT.

#### 13. MODEL CODE OF CONDUCT:-

With the announcement of this Schedule for the conduct of DDC and Panchayat By-Elections, through this Press Note, provisions of Model Code of Conduct (Annexure –II) shall come into force with immediate effect. All the provisions of the Model Code will apply to all the Panchayat Halqas (Rural Areas) falling under the DDCs mentioned in this schedule and will be applicable to all the candidates, political parties and UT/Central Government. Control Rooms have been established in all the districts for prompt action on any complaints; details shall be made available on the website. The Model Code shall cease to apply once the election process is over in a particular Block.

#### 14. SCHEDULE:-

In terms of Rule 7 and Rule 108-F of the Jammu & Kashmir Panchayati Raj Rules, 1996, the Government in Rural Development Department, J&K has issued two separate Notifications calling upon the Panchayat Halqas to elect Sarpanches and Panches vide its S.O. 304 dated 01-10-2020, and the constituencies to elect District Development Councils vide S.O. 336 dated 29<sup>th</sup> October, 2020 respectively, annexing therewith the respective details of the vacant Sarpanch and Panch constituencies and of the DDCs where elections would be held. As per S.O. 304, there are 146 blocks in Jammu Division and 128 blocks in Kashmir Division where Panchayat by-election is being held.

After taking into consideration all relevant factors and inputs from various stake holders and considering various holidays and festivals during the months of November and December, 2020, the Election Authority, J&K has prepared following Schedule for holding DDC Election-2020 and Panchayat By-Elections-2020 in all the DDCs mentioned in Annexure to S.O. 336 dated 29<sup>th</sup> October 2020 and the Panchayat Halqas and Panch Wards as mentioned in the Annexures to S.O. 304 dated 01-10-2020 issued by the Rural Development and PR Department:-

#### **SPECIAL INSTRUCTIONS IN VIEW OF COVID-19 PANDEMIC:**

In view of the prevailing situation due to Covid -19 pandemic, the Elections are not just required to be free and fair but also SAFE for all stake holders, including the electors. Accordingly, the Election Authority has circulated to all concerned a detailed list of SPECIAL MEASURES TO BE TAKEN for making these elections Covid safe. Nodal Health Officer shall be designated for the UT, the District and the Block Level to oversee COVID-19 related arrangements and, preventive measures during entire electoral process. However, generally it has been directed that:

- A. Every person shall wear face mask during every election related activity.
- B. At the entry of hall/room/premises used for election purposes:
  - (a) Thermal Scanning of all persons shall be carried out;
  - (b) Sanitizer, soap and water shall be made available.
- C. Social distancing shall be maintained as per the extant COVID-19 guidelines of the UT Govt. and Ministry of Home Affairs.
- D. As far as practicable, large halls would be utilized to ensure social distancing norms.
- E. Adequate number of vehicles shall be mobilized for movement of polling personnel, security personnel to ensure compliance of COVID-19 guidelines.
- F. Number of persons to accompany candidate for submission of Nomination shall be restricted to One (1) and also the number of vehicles for the purposes of nomination shall also be restricted to One (1).
- G. **Door to Door Campaign** Subject to any other restriction(s) including extant COVID-19 guidelines, a group of 3 (three) persons including candidates, excluding security personnel, if any, shall be allowed for do door to door campaigning.
- H. Election Meetings Public gatherings/ rallies may be conducted subject to adherence to extant COVID-19 guidelines.

#### I. At the Polling Stations:

- a. Mandatory sanitization of Polling Station, preferably, a day before the poll.
- **b.** Thermal scanning of voters at entry point of polling station location/Polling station, either by polling staff or Para Medical staff or Asha worker.
- c. If temperature is above the set norms of MoHFW at first reading, then it will be checked twice and if it remains, then the elector shall be provided with token/certificate and will be asked to come for voting at the last hour of poll. At the last hour of poll, such electors shall be facilitated voting, strictly following COVID-19 related preventive measures.
- d. Soap and Water shall be provided at the entry/exit point of every polling station.
- e. Sanitizer would be provided at the entry/exit point of every polling station.
- f. Face Masks in reserves for those electors who are not carrying the mask will be kept.

# MODEL CODE OF CONDUCT FOR THE GUIDANCE OF CANDIDATES AND THE POLITICAL PARTIES

In exercise of powers conferred under Section 36 of the Panchayati Raj Act, 1989, the Election Authority issues the following Model Code of Conduct to promote free and fair Elections to the Panchayati Raj Institutions.

This order shall be known as Code of Conduct for Political Parties and Contesting Candidates and shall come into force with effect from the date of elections are notified by the Election Authority Under Panchayati Raj Act, 1989.

#### I. General Conduct

- (1) No party or candidate shall indulge in any activity, which may aggravate existing differences or create communal hatred or cause tension between different castes and communities, religious or linguistic.
- (2) Criticism of other political parties, when made, shall be confined to their policies and programme, past record and work. Parties and Candidates shall refrain from criticism of all aspects of private life, not connected with the public activities of the leaders or workers of other parties. Criticism of other parties or their workers based on unverified allegations or distortion shall be avoided.
- (3) There shall be no appeal to caste or communal feelings for securing votes.

  Mosques, Churches, Temples or other places of worship shall not be used for election propaganda.
- (4) All parties and candidates shall scrupulously avoid all activities which are "corrupt practices" and offences under the election law, such as bribing of voters, intimidation of voters, impersonation of voters, canvassing within 100 meters of polling stations, holding public meetings during the period of 48 hours ending with the hour fixed for the close of the poll, and the transport and conveyance of voters to and fro polling station.
- (5) The right of every individual for peaceful and undisturbed home-life shall be respected, however much the political parties or candidates may resent his political opinions or activities. Organizing demonstrations or picketing before the houses of individuals by way of protesting against their opinions or activities shall not be resorted to under any circumstances.

- (6) No political party or candidate shall permit its or his followers to make use of any individual's land, building, compound wall etc., without his permission for erecting flag-staffs, suspending banners, pasting notices, writing slogans etc.
- (7) Political parties and candidates shall ensure that their supporters do not create obstructions in or break up meetings and processions organized by other parties. Workers or sympathisers of one political party shall not create disturbances at public meetings organized by another political party by putting questions orally or in writing or by distributing leaflets of their own party. Processions shall not be taken out by one party along places at which meetings are held by another party. Workers of one party shall not remove posters issued by another party.

#### II. Meetings

- (1) The party or candidate shall inform the local police authorities of the venue and time of any proposed meeting well in time so as to enable the police to make necessary arrangements for controlling traffic and maintaining peace and order.
- A Party or candidate shall ascertain in advance if there is any prohibitory order or other restrictions in force in the place proposed for the meeting. If such orders exist, they shall be followed strictly. If any exemption is required from such orders, it shall be applied for and obtained from the concerned authority such as District Magistrate, Sub-Divisional Magistrate, Executive Magistrate or the concerned Police Officer well in time.
- (3) If permission or license is to be obtained for the use of loudspeakers or any other facility in connection with any proposed meeting, the party or candidate shall apply to the authority concerned well in advance and obtain such permission or license.
- Organizers of a meeting shall invariably seek the assistance of the police on duty for dealing with the persons disturbing a meeting or otherwise attempting to create disorder. Organizers themselves shall not take action against such persons.

#### III. Procession

(1) A Party or candidate organizing a procession shall decide before hand the time and place of the starting of the procession, the route to be followed

- and the time and place at which the procession will terminate. There shall ordinary be no deviation from the programme.
- (2) The organizers shall give advance intimation to the local police authorities of the programme so as to enable the letter to make necessary arrangement.
- (3) The organizers shall ascertain if any restrictive orders are in force in the localities through which the procession has to pass, and shall comply with the restrictions unless exempted specially by the competent authority. Any traffic regulations or restrictions shall also be carefully adhered to.
- (4) The organizers shall take steps in advance to arrange for passage of the procession so that there is no blockade or hindrance to traffic. If the procession is very long, it shall be organized in segments of suitable lengths, so that at convenient intervals, especially at points where the procession have to pass road junctions, the passage of held-up traffic could be allowed by stages, thus avoiding heavy traffic congestion.
- (5) Processions shall be so regulated as to keep as much to the right of the road as possible and the direction and advice of the police on duty shall be strictly complied with.
- (6) If two or more political parties or candidate propose to take processions over the same route or parts thereof at about the same time, the organizers shall establish contact well in advance and decide upon the measures to be taken to see that the processions do not clash or cause hindrance to traffic. The assistance of the local police shall be availed of for arriving at a satisfactory arrangement. For this purpose, the parties shall contact the police at the earliest opportunity.
- (7) The political parties or the candidates shall exercise control to the maximum extent possible in the matter of processionists carrying articles, which may be put to misuse by undesirable elements especially in moments of excitement.
- (8) The carrying of effigies purporting to represent the members of other political parties or their leaders, burning such effigies in public and such other forms of demonstration shall not be countenanced by any political party or candidate.

#### IV. Polling Day

All Political parties and candidates shall:-

- 1) Co-operate with the officers on election duty to ensure peaceful and orderly polling and complete freedom to the voters to exercise their franchise without being subjected to any annoyance or obstruction.
- 2) Supply to their authorized workers suitable badges or identity cards.
- Agree that the identity slip supplied by them to voters shall be on plain (white) paper and shall not contain any symbol, name of the candidate or the name of the party.
- 4) Refrain from serving or distributing liquor on polling day and during the 48 hours preceding it.
- Not allow unnecessary crowd to be collected near the camp set up by the political parties and candidates near the polling booths so as to avoid confrontation and tension among workers and sympathizers of the political parties and the candidates.
- 6) Ensure that the candidate's camps shall be simple. They shall not display any posters, flags, symbols or any other propaganda material. No eatable shall be served or crowd allowed at the camps; and
- 7) Co-operate with the authorities in complying with the restrictions to be imposed on the plying of vehicles on the polling day and obtain permits for them which should be displayed prominently on those vehicles.

#### V. Polling Booth

Excepting the voters, no one without a valid pass from the Deputy Commissioner of the District shall enter the polling booths.

#### VI. Observers

The Election Authority is appointing Observers to over-see the conduct of Elections. If the candidates or their agents have any specific complaint or problem regarding the conduct of election they may bring the same to the notice of the Observer.

#### VII. Party in Power

The party or parties in power in the Centre or State or Union Territory shall ensure that no cause is given for any complaint that they have used its official position for the purposes of its election campaign and in particular:-

 (a) The Ministers shall not combine their official visit with electioneering work and shall not also make use of official machinery or personnel during the electioneering work.

- (b) Government transport including official aircrafts, vehicles, machinery and personnel shall not be used for furtherance of the interest of the party in power;
- Public places such as maidans, etc., for holding election meetings, and use of helipads for air-flights in connection with elections shall not be monopolized by the ruling parties. Other parties and candidates shall be allowed to use such places and facilities on the same terms and conditions on which they are used by the parties in power;
- Rest houses, dak bungalows or other Government accommodation shall not be monopolized by the party in power or its candidates and such accommodation shall be allowed to be used by other parties and candidates in a fair manner but no party or candidate shall use or be allowed to use such accommodation (including premises appertaining thereto) as a campaign office or for holding any public meeting for the purposes of election propaganda;
- 4) Issue of advertisement at the cost of public exchequer in the newspapers and other media and the misuse of official mass media during the election period for partisan coverage of political news and publicity regarding achievements with a view to furthering the prospects of the party/parties in power shall be scrupulously avoided.
- 5) Ministers and other authorities shall not sanction grants/payments out of discretionary funds from the time elections are announced; and
- 6) From the time elections are announced, Ministers and other authorities shall not:-
  - (a) announce any financial grants in any form or promises thereof; or
  - (b) (except civil servants) lay foundation stones etc. of projects or schemes of any kind; or
  - (c) Make any promise of construction of roads, provision of drinking water facilities etc.; or
  - (d) Make any ad-hoc appointments in Government, PSUs, etc. which may have the effect of influencing the voters in favour of the party in power.
- 7) Ministers of the Central or State or Union Territory Government shall not enter any polling station or place of counting except in their capacity as a candidate or voter or authorized agent.
