WHEREAS, the Government of Jammu and Kashmir, vide SRO No. 540 dated 20th September, 2019 issued notification under Rule 102-A of the Jammu and Kashmir Panchayati Raj Rules, 1996, calling upon elected members of all the Halqa Panchayats of blocks to elect the Chairpersons of the Block Development Councils ; and

WHEREAS, the Election Authority vide its press note dated 29th September, 2019 has announced the schedule for election of Chairperson of Block Development Councils in the State ;

NOW, THEREFORE, in exercise of the powers conferred under section 36 of Jammu and Kashmir Panchayati Raj Act, 1989, and in pursuance of the sub rule I of Rule 103 of the Jammu and Kashmir Panchayati Raj Rules, 1996, the Election Authority, J&K (Chief Electoral Officer, J&K) hereby appoints the following dates for the conduct of election of the Chairperson of the Block Development Councils in Blocks mentioned in Annexure-A appended to this notification :—

- (a) the 1st October, 2019 (Tuesday) as the date of issuance of the Gazette Notification.
- (b) the 9th October, 2019 (Wednesday) as-the last date for making nominations.
- (c) the 10th October, 2019 (Thursday) as the date for the scrutiny of nominations.
- (d) the 11th October, 2019 (Friday) as the last date for withdrawal of candidature.
- (e) the 24th October, 2019 (Thursday) as the date on which a poll, if necessary, shall be taken from 09.00 a. m. to 01.00 p. m.
- (f) the 24th October, 2019 (Thursday), 3.00 p.m. onwards as the date and time of counting, unless notified otherwise.
- (g) the 5th November, 2019 (Tuesday) as the date before which the election shall be completed.
