PRESS NOTE

PANCHAYAT ELECTION:-

The Panchayat Election were held in the State in the year 2018 in nine phases from 17th November 2018 to 11th December 2018. The election process was completed by 17th December, 2018. A total of 23629 Panches and 3652 Sarpanches were returned by the respective Returning Officers.

ELECTION OF THE CHAIRPERSON OF BLOCK DEVELOPMENT COUNCILS:

Election of Chairperson of Block Development Councils shall be held on Party lines.

For the conduct of election of Chairperson of the Block Development Councils, one Block is taken as one constituency and all the elected Panches and Sarpanches of the Halqa Panchayats falling within the block constitute the Electoral College for that block.

The Department of Rural Development and Panchayati Raj issued SRO 522 dated 03-09-2019 Notifying the Block Development Councils along with their constituent panchayat halqas. Out of the 316 blocks in the State there are two blocks where there are no elected panches or Sarpanches and thus there shall be no election there. There are 4 blocks where no women Panch/Sarpanch is available which are reserved for women as per the reservation notification issued by the Department of Rural Development and Panchayati Raj.

ELECTORAL ROLLS:-

Photo Electoral rolls have been prepared by following the due process of appointing Electoral Registration Officers and Assistant Electoral Registration Officers for all Blocks. The process started on 14th of September and culminated on 23rd of September with the publication of Final Electoral Roll for each Block. There is one single electoral roll for one block. Copies of Electoral Rolls are available at the Block headquarters vide their No.02-DRDK of 2019 dated 24/07/2019 and No. 05 of 2019 dated 04/09/2019.

RESERVATION OF CONSTITUENCIES:-

Notification with regard to reservation of Sarpanch/Panch Constituencies for Schedule Caste, Schedule Tribes and Women as per provision of the Act and Rules governing Panchayat Elections have been issued by the competent authority i.e., Directors of Rural Development Department, J&K. Details are as under:

POLLING STATIONS

There shall be one polling station for one Block Development Council. Accordingly, 310 polling stations have been setup in the State, one in each block where elections are being notified.

ELECTORS PHOTO IDENTITY CARDS (EPIC)/ALTERNATE DOCUMENTS:

The Election Authority has decided that compulsory identification of voters will be made in the these Elections. Electors who have got their EPIC shall be identified through EPIC. However the Election Authority has also notified a list of alternative documents which can also be used for the purpose of identification, by the electors who are yet to be provided EPICs. These includes Passport, Driving Licence, Bank /Post office passbooks with photographs, Income Tax Identity (PAN) Card, Aadhaar Card, Pension documents such as ex-servicemen's pension payment order, Ex-Servicemen's widow/Dependent certificates, Old Age pension order and Widow Pension order with photographs

BALLOT BOXES

Ballot boxes would be used during the elections of the Chairperson of the Block Development Councils as the election shall be held through secret ballot. Sufficient number of ballot boxes have been made available to the District Panchayat Election Officers for smooth conduct of these elections.

OBSERVERS

General Observer shall be deployed to ensure free and fair Elections. The observer will be asked to keep a close watch on every stage of the electoral process. Their names, addresses within the district and their telephone numbers will be publicized.

ELECTION EXPENDITURE MONITORING

Comprehensive instructions for the purpose of effective monitoring of the election expenditure of the candidates have been issued. For greater transparency and for ease of monitoring of election expenses, Candidates would be required to open a separate bank account and incur their election expenses from that very account. Control Room and complaint monitoring centers at the District level shall be operative during the entire election process. All the candidates have to ensure that they maintain day-to-day expenditure record in the prescribed register, which will be supplied to the contesting candidate in the form of 'Expenditure Register', from the date of nomination to the date of declaration of result. The Election Authority has fixed the limits of expenditure to be incurred by the Contesting Candidate as Rs 200000/-. General Observers shall function as Expenditure Observer as well.

VIDEOGRAPHY

All critical event will be videographed. District Panchayat Election Officers (Deputy Commissioners) will arrange sufficient numbers of video and digital camera teams for the purpose. The events for videography will include filing of nomination, scrutiny thereof and allotment of

symbols, storage and distribution of Ballot Boxes, important public meetings, processions etc., during campaign, process of dispatching of postal ballot papers, polling process and counting of votes.

MODEL CODE OF CONDUCT:-

With the announcement of this Schedule for the conduct of election of the Chairperson of the Block Development Councils, through this Press Note, provision of the Model Code of Conduct shall come into force with immediate effect. All the provisions of the Model Code will apply to all the Panchayat Halqas (Rural Areas) and will be applicable to all the candidates, political parties and the State/Central Government.

SCHEDULE:-

In terms of Rule 102-A of the Jammu & Kashmir Panchayati Raj Rules, 1996, the Government in Rural Development Department J&K has issued the Notification calling upon all the Panches and Sarpanches to elect Chairpersons of the Block Development Councils vide its SRO No 540 dated 20th September, 2019.

Election Authority, J&K has prepared the Schedule for holding of these elections, after taking into consideration of all relevant aspects. The election shall be held in one single phase across the State. Important dates are as under:-
