NOTIFICATION

Whereas, in pursuance of Rule 7 of the J&K Panchayati Raj Rules, 1996, the Government had issued a Notification, in consultation with the Election Authority (Chief Electoral Officer, J&K), vide its SRO No.78 dated 14th March, 2011, calling upon the Panchayat Halqas in the State to elect Sarpanches and Panches on the dates to be appointed by Election Authority (Chief Electoral Officer, J&K);

Whereas, in pursuance of Rule 8 of J&K Panchayati Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) had issued a Notification on 22nd March, 2011, notifying the dates for the 2nd Phase of Election for Sarpanches and Panches in respect of Blocks Wavoora, Uri, Lar, Nagam, Pahloo, Chenani, Vijaypur and R.S.Pura as per the schedule given below:-

- 22nd March, 2011 as date of issue of Gazette Notification,
- 29th March, 2011 last date for making Nominations,
- 30th March, 2011 date of Scrutiny of Nominations,
- 1st April, 2011 last date for withdrawal of candidate,
- 17th April, 2011 date of poll/counting wherever, necessary,

Whereas, vide Notification dated 4th May, 2011, the re-poll for Panch Constituency No.10 Nagam of Panchayat Halqa BD-222 Nagam Block Nagam was ordered to be held on 12-05-2011 between 08:00 a.m. to 2:00 p.m.;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Budgam vide its letter No.DPEO/DC/Bud/2011/1992-95 dated 05-05-2011 has intimated that as per sub Rule (1) of Rules 4 of J&K Panchayati Raj Rules, 1996, the Director, Rural Development Department shall fix the territorial limits of each constituency in a Panchayat Halqa and number them in a serial order, provided that, as far as possible, the number of electors in each constituency shall be equal;


Whereas, the District Panchayat Election Officer (Deputy Commissioner) Budgam has further intimated that the position of electors of other Panchayat Constituencies in the Panchayat Halqa Nagam is depicted as under:-

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Budgam has submitted that from the above position it is clear that the number of electors in Constituency No.X-Nagam are not in conformity to the above said rule position viz-a-viz, the number of electors in other Panch Constituencies and has become impossible to carry out the re-poll process in the Panch Constituency No.10 Nagam of Panchayat Halqa BD-222 Nagam Block Nagam where only six electors have been left after the names of 157 migrant electors have been deleted;

Now, therefore, in exercise of the powers conferred under Section 36 of the J&K Panchayati Raj Act, 1989 read with rule 3 of J&K Panchayat Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) hereby issues directions that the Notification dated 22nd March, 2011 issued for the conduct of elections and Notification dated 4th May, 2011 issued for re-poll in respect of Panch Constituency No.10 Nagam of Panchayat Halqa BD-222 Nagam Block Nagam is hereby rescinded. A suitable decision will be taken subsequently.
