**PUBLIC NOTICE**

Whereas, in pursuance of Section 43 of the J&K Panchayati Raj Act, 1989 read with Rule 43 of the J&K Panchayati Raj Rules, 1996, the election of a person as a Sarpanch or a Panch of a Halqa Panchayat or as a Chairman of the Block Development Council shall not be called in question except by an application/appeal presented to an Authority as may be prescribed/notified by the Government, within a period of 30 days from the date of declaration of result;


