Whereas, as reported by District Panchayat Election Officer (Dy. Commissioner) Udhampur, one of the candidate namely Shri Shanker Dass has objected to the ballot paper printed for the Panchayat Kither on day of poll i.e. 17.04.2011 on the plea that while he had been allotted symbol of "Pressure Cooker" and that he had campaigned with this symbol in the Kither Sarpanch halqa, but his symbol was shown on ballot paper as "Gas Cylinder";

Whereas Shri Shanker Dass the contesting candidate had further alleged that the wrong of allotment of symbol had resulted into loss of votes;

Whereas the Returning Officer Kither has also submitted his report vide No: Chenani RO/Gujad/02 dated 17.04.2011 to DPEO, Udhampur and admitted that due to clerical error a wrong symbol has been published on the ballot paper against the
