- a) the 17th November, 2018 (Saturday) as the date of issuance of the Gazette Notification.
- b) the 22nd November, 2018 (Thursday) as the last date for making nominations.
- c) the 24th November, 2018 (Saturday) as the date for the scrutiny of nominations.
- d) the 26th November, 2018 (Monday) as the last date for withdrawal of candidature.
- e) the 4th December 2018 (Tuesday) as the date on which a poll, if necessary, shall be taken from 08:00 a.m. to 02:00 p.m.
- f) the 4th December 2018 (Tuesday) as the date of counting, unless notified otherwise.
- g) the 17th December, 2018 (Monday) as the date before which the election shall be completed.
