Whereas, the State Election Commission, vide No. 5413/CEO/Pyt/2019/SEC-15/2024/5462-88 dated 09-12-2024 has revised and the schedule for revision of Panchayat Electoral Roll 2025.

Whereas, the Period of Filing Claims and Objections for the Additions/deletions/Corrections/Transportation in the Panchayat Electoral Rolls-2025 was prescribed from 11.11.2024 (Monday) to 20-12-2024 (Friday).


Whereas, the date for disposal of claims and objections by ERO was extended upto 30-12-2024 (Monday) and the date for Publication of Final Panchayat Electoral Rolls-2025 was extended upto 15-01-2025 (Wednesday)

The Commission has received the request from various districts for extending the date of punching of forms, due to receipt of a large number of forms (claims & objections) on fag end and their punching is still pending.

In view of these, the Commission therefore, has revised dates for revision of electoral roll as under:-
