Reservation Notification

**DATED 27-10-2020**

Whereas, Section 45 of the Jammu and Kashmir Panchayati Raj Act 1989 (as amended by S.O. 3654(E) dated 16-10-2020 of the Ministry of Home Affairs, Government of India) envisages establishment of a District Development Council having jurisdiction over the entire district excluding such portion of the district as are included in a Municipality or Municipal Corporation constituted under any law for the time being in force;

Whereas, sub-Section 2 of Section 45-A of the Jammu and Kashmir Panchayati Raj Act 1989 read with Rule 108-A (1) and (2) of the Jammu and Kashmir Panchayati Raj Rules 1996 (as amended by S.O. 316 dated 17-10-2020 of Department of Rural Development and Panchayati Raj, Government of Jammu and Kashmir) the Rural area of district was divided into Fourteen (14) single member territorial constituencies notified vide Chief Electoral Officer J&K Notification No EA/Pyt/2020/02 dated 26.10.2020.

Whereas, section 45-A of the Jammu and Kashmir Panchayati Raj Act 1989 read with Rule 108-A (sub rules - 3, 3A,3B,3C,3D & 3E) of the Jammu and Kashmir Panchayati Raj Rules 1996 (as amended by S.O. 330 dated 24-10-2020 of Department of Rural Development and Panchayati Raj, Government of Jammu and Kashmir) envisages reservation and lays down procedure of reservation for women, Scheduled caste and Scheduled Tribe population.

Now therefore in terms of Rule 108-A(3) I Anshul Garg (IAS) Deputy Commissioner Kupwara do hereby notify the draft reservation for DDC constituencies of District Kupwara as Annexure A to this notification for information and invite objections for the same. Any objection to this draft reservation may be submitted in writing before the Undersigned during office hours by or before 31<sup>st</sup> October 2020.
