Whereas, in terms of section (45) of the Jammu & Kashmir Panchayati Raj Act, 1989 (as amended by S.O. 3654 (E) dated: 16.10.2020 of the Ministry of Home Affairs Govt. of India) read along with Rule 108-20 of the Jammu and Kashmir Panchayati Rules, 1996 (as amended by S.O. 316 Dated: 17.10.2020 and S.O. 330 dated 24.10.2020 of Department of Rural Development & Panchayati Raj Govt. of Jammu & Kashmir), the Election Authority, Jammu & Kashmir Panchayati Raj Act 1989 has notified the final delimitation of District Development Council Constituencies, vide Notification No: EA/Pyt./2020/02 dated:- 26th of October 2020;

Constituencies in a District;

Now, therefore in terms of Rule 108-A (3) and based on the procedure laid down in Rules 108-A (3, 3A, 3B, 3C, 3D and 3E) I, **Dr. Piyush Singla, IAS** Deputy Commissioner, Udhampur do hereby notify the draft reservation of District Development Council Constituencies as **Annexure—A** to this notification and invite objections/suggestions to the same. Objections/Suggestions, if any, must be submitted in writing to the Deputy Commissioner by or before **31**st **October 2020.**
