Sir,


In order to ensure free and fair District Development Council (DDC) and Panchayat By-Elections 2020 in the UT of Jammu and Kashmir, the State Election Commissioner (Election Authority, Jammu and Kashmir Panchayati Raj Act 1989) has desired that,

"No spirituous, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a hotel, eating house, tavern, shop or any other place, public or private, within a polling area during the period of forty-eight hours ending with the hour fixed for the conclusion of the poll for any election, under the Jammu and Kashmir Panchayati Raj Act 1989, in the polling area. Similar prohibition shall also be enforced on the day of counting in each constituency."

Accordingly, I am directed to request you to notify 'dry day' in the District Development Councils going to poll/counting as per the schedule annexed herewith.

Matter may kindly be treated as election urgent.

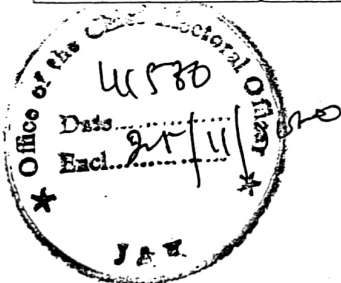
